総合政策学部、環境情報学部、政策・メディア研究科では新たな環境情報学を開拓するために5名の教員を同時に募集いたします。

本公募では、SFC の環境情報学を新たな段階に導くために最大 5 名の教員を同時に募集するものです。自然科学を基盤とした環境情報学に軸足を置きつつ、総合政策学部の学問領域とも連携し、新たな環境情報学を生み出していける人材を募集します。加えて、SFC に着任以降、これまでのご自身の専門分野を越えて、新たな領域を生み出すことができる人材を求めています。

Call for Faculty Members to Teach Environment and Information Studies

The Keio University Faculty of Policy Management, Faculty of Environment and Information Studies, and Graduate School of Media and Governance are seeking five faculty members to develop new fields of study in Environment and Information Studies.

Keio University opened the Shonan Fujisawa Campus (SFC) in 1990 and established the Faculty of Environment and Information Studies, making Keio the first university in Japan to have a "Faculty of Environment and Information Studies." Environment and Information Studies at SFC is not limited to areas relevant to environment and information but opens up a number of new fields and domains ahead of the times. Meanwhile, a quarter-century has almost passed since the beginning of the 21st century, and environmental issues are becoming more critical than ever. In addition, the importance of information has dramatically increased, not to mention the rapid development and spread of generative AI in recent years. To respond to the complex challenges of the global environment and our society, there is an urgent need to train students with creative talents who can integrate disciplines through Environment and Information Studies.

We invite applications for five faculty members to lead the SFC's Environment and Information Studies to a new stage. Particularly, we are looking for individuals who can pave the way for a new discipline in the area of Environment and Information Studies, while focusing on the Environment and Information Studies based on natural science and collaborating across disciplines in the Faculty of Policy Management. After taking the position, the successful applicants are expected to go beyond their expertise up to that point to pioneer new fields of study.

Eligible positions are tenured faculty member, faculty member (non-tenured), and faculty member (fixed-term and tenure-track). "Tenured faculty members" are faculty members with tenure (the retirement age at Keio University is 65). "Faculty members (non-tenured)" are appointed for up to five years (single-year contract), and "faculty members (fixed-term and tenure-track)" are appointed for up to five years (single-year contract), after which they will be promoted to tenured faculty members if they pass a tenure review during their term. Candidates who pass the document screening and become eligible for the second round of the review process (first interview) will be notified which position they will be selected for before the second round.

Keio University has been hiring faculty members who have strong enthusiasm and interests in education as well as research. In particular, as Seminars are the core of the curriculum at the Faculty

of Environment and Information Studies and the Faculty of Policy Management, working with students on their research at the Seminars is one of the most necessary competencies. The successful candidates are expected to teach at least one data science or informatics course. In addition, they must hold one or more classes in English.

Keio University promotes diversity based on its Charter for the Promotion of Equity, Diversity, and Inclusion. The university will ensure that no individual will be subject to discrimination because of their age, gender, sexual orientation and gender identity (SOGI), disability, culture, nationality, race, beliefs, or lifestyle in personnel evaluations for the recruitment and promotion of faculty members.
