Applicants who hold nationality from the Philippines / Vietnam / Indonesia / Nepal / Myanmar / China

Regarding the “Japan Pre-Entry Tuberculosis Screening (JPETS) ”

1. Overview

When applying for the Certificate of Eligibility (COE), those who have an obligation to take JPETS will be required to submit a "TB Clearance Certificate" in addition to the usual application documents in order to prove that you are not infected with tuberculosis (TB).

2. Those who must take JPETS;

Principles	Those who meet all the following conditions; <ul style="list-style-type: none">- Those who are applying for COE (including reapplicants) to stay in Japan for more than three months.- Those who are nationals of the TB screening target country designated by the MHLW*.
Exceptions	<ul style="list-style-type: none">- Those who are nationals of the TB screening target country, <u>but are currently residing in an another country</u> (only if you can prove that your current place of residence is in a country/region other than the designated country by using a “residence permit”, etc.)* For the details, refer to the notes written in “4. Others” in this document.- Those who have Japanese nationality in addition to the nationality of the TB screening target country (dual nationality).

* Details of the TB screening target country and the schedules are as below;

TB screening target country	Starting date of the submission of “TB Clearance Certificate”
Philippines, Nepal	from June 23, 2025
Vietnam	from September 1, 2025
Indonesia / Myanmar / China	To be decided * This information will be updated on this document as soon as it is announced on the special website. * As long it is stated “To be decided” above in this document, you do not need to prepare a “TB Clearance Certificate”.

3. Required Procedures

- Please undergo the TB screening at the [designated panel clinics](#) in your country and receive the "TB Clearance Certificate". Please submit it together with the other COE application documents by the specified deadline and in the specified manner.

- **You must visit the clinic AFTER the designated date (Spring Enrollment: “October 1st of the year before”, Fall Enrollment: March 21st of the same year), and BEFORE the “the deadline of your COE application documents specified by the University”.**

- * If the date of your TB screening is too early, there would be a risk that it will expire by the time you apply for the COE, since the validity period of the "Tuberculosis Free Certificate" is 180 days.
- * If the date of your TB screening is too late, you may not be able to obtain the "Tuberculosis Free Certificate" by the deadline for submitting the COE documents, so please prepare well in advance.

4. Others

- In case you were infected by TB and unable to prepare the "TB Clearance Certificate", please contact the Office of International Affairs at Keio Shonan Fujisawa Campus at sfc-visa@adst.keio.ac.jp as soon as possible.
- If this situation came upon you and cannot come to Japan, you may be eligible for a special leave of absence (with no tuition and other expenses).
- In case you found out you are unable to enter Japan just before the enrollment, it may seriously impact your future plans. Therefore, we strongly recommend that you undergo the TB screening at an early stage, separate from the one for the COE application, to confirm that you are not infected.
- Those who are nationals of the TB screening target country, but are currently residing in another country, may submit the following documents in lieu of a "TB Clearance Certificate".

1	A copy of your residence permit or other document proving your current country of residence (including scanned data).
